

Tuesday Morning Ladies 2022-2023 Constitution

Rule1: League Information and League Schedule

The name of the league shall be: **Tuesday Morning Ladies** and will consist of 10 teams with a playing strength of 4 ladies each. Team roster will be limited to 4 members. Team captains will turn in a roster of team members the first day of bowling. The league will bowl on Tuesday morning at 9:10 AM starting on August 9, 2022. The league will allow new members or new teams to join at any time within reason. Any additional teams will be allowed to make up the games missed. In the event of an odd number of teams in the league, the team bowling the vacant team must bowl within 40 pins of their current team average plus handicap to win the game(s). All points must be earned, there are no automatic forfeits. This league is open to women of the age of 18 and older and in good standing with USBC.

Standings will be based on a 4-point system with 1 point for each game won and 1 point for series.

The league will bowl for 33 weeks, with **April 4, 2023**, being the final week of bowling and **April 11, 2023** being the No-Tap and awards week.

We will not bowl on:

November 22, 2022 - Thanksgiving

December 27, 2022 - Christmas

Rule 2: Management

Management of the league will be vested in the Board of Directors, consisting of the League Officers and team Captains. The entire league shall elect officers and adopt league rules. A majority shall constitute a quorum.

Rule 3: League Fees, Salaries, and Funds

The amount to be paid each week by each member shall be \$15.00 of which \$10.00 will be paid to the bowling establishment for lineage. The remainder \$4.00 for prize fund and \$1.00 for secretary fee. The funds will be deposited in the league account held at Redstone Federal Credit Union weekly. Funds will be verified by the League President each month. Checks to be signed by Secretary and President of the league.

It is the Team Captains responsibility to collect fees from her team members and to ensure the team pay envelope is properly marked. It is the Team Captains responsibility to turn the pay envelope in to the League Secretary/Treasurer no later than the end of the 1st game. No team members will be allowed to be more than 1 week in arrears. Anyone in arrears more than 2 weeks will be considered ineligible and will not be permitted to bowl until arrearage is made up. Any team bowling with an ineligible bowler may forfeit any games bowled.

Teams must pay the **final 2 weeks** of bowling in advance, no later than the **5th week** of the season.

The Secretary/Treasurer duties will be combined. The Secretary shall not receive her salary until the prize fund is distributed and the final averages have been turned into the Association Manager with 15 days of league completion.

If a team has a player listed on their roster on the day of bowling, whether they are present to bowl or not, the rostered player or the team is responsible for payment of league amount of \$15.00. This will need to be paid for every week the bowler is listed on the roster.

Rule 4: Prize and Awards

The prize fund from the 2022 season will remain in effect.

A bowler or team may qualify for only 1 award in the game or series categories. Series awards will have priority over game awards, with handicap awards priority over scratch.

Set as follows:

Handicap Series

Handicap Game

Scratch Series

Scratch Game

A team with a vacancy will try to get a bowler to fill the position. If one is not found, the prize fee for that vacancy will come out of the general prize fund.

Individuals must bowl at least 2/3 (66 games) of the season to qualify for individual awards. Most improved bowler awards will begin after 21 games bowled. Bowlers who achieve individual high average are not eligible for most improved bowler.

Team and individual handicap awards will not be computed until after 12 games. Scratch awards will begin the first day of bowling.

In the case of a tie for any position other than first place (see Rule 113a) money shall be combined and divided equally.

Rule 5: Entering Averages and Handicap

Bowler will establish averages the first day of bowling. Handicap will be based on 100% of 200.

Rule 6: Subs, Lineup, Tardy, Absentee and Vacant Scores

Substitutes will be permitted. All substitutes must fill out a USBC card and pay their sanction fees if they are not already sanctioned on another league. The absent bowler is responsible for the fees.

One member from the current team roster will make a legal lineup. She must be present to bowl at the start of the first game, or that game may be declared a forfeit. Tardy players may enter the 1st game provided they are present and ready to bowl no later than the last ball of the 3rd frame of the 1st game. A legal lineup must be present at the start of any subsequent game or they will be declared a forfeit. A league Officer may only declare a game forfeit. **If a game is declared a forfeit, the team bowling against the forfeit team must bowl within 40 pins of their own average, plus handicap to win the game.** In the case of a loss by the team bowling against the forfeit team, no points will be awarded as a win.

Absentee (blind) scores will be the absent bowlers current average minus 10 pins. The absent bowlers normal handicap will be used. If there are 2 absent bowlers on a team, and only one sub is used, the absent bowlers score must be the bowler with the most games bowled. If both bowlers have the same number of games bowled, the bowler with the higher average of the 2 shall use the absentee score.

In the case of a vacancy for bowler, the vacant score shall be 120 with a handicap of 80.

Rule 7: Pre-Bowling and Postponements

Only League Officers will grant Pre-Bowls and Postponements. This will be granted if a team cannot appear due to reasons beyond its control. If a legal lineup is able to bowl, a Pre-Bowl or Postponement will not be granted. Individuals will not be able to Pre-Bowl or Post Bowl only Teams. Post Bowls must be made up by the next week of bowling. **Pre or Post Bowls can only be bowled on a Tuesday or Thursday evening after 7:00 or on a Sunday.**

Rule 8: Position Rounds and Playoff

The league will bowl 2 position rounds them being week 16 and the final week of league.

In the event that teams are tied for position, the team with the highest handicap pin total assumes the higher position for the purpose of lane assignments.

Substitutes are authorized during position rounds. Subs must be within 20 pins of the absent players average in order to compete and she must have bowled at least 9 games as of the date of the position round.

In the case of a tie for 1st Place at the end of the season, a roll off consisting of 3 games will determine the league champion by points won.

Should a tie still exist after the 3game match, total pins **CANNOT** determine the league champion. (See rule 113b and d for tie in roll off)

Rule 9: Rule Discrepancies

All rules not covered in these laws will be in compliance with the current USBC rulebook. The League Board of Directors will resolve any conflict.
