LOGSA Bowling League Bylaws 2025-2026

League Management: The LOGSA League will not be a managed league. The league Board of Directors, which consists of all league officers and team captains, shall manage the league. A majority of the Board of Directors present shall constitute a quorum. Adoption of rules will be conducted by membership prior to season starting. USBC 102c

LOGSA League will be sanctioned with the United States Bowling Congress and The National Bowling association Inc. USBC league Rule 101 will be enforced to remain a USBC sanctioned league.

USBC - \$28.00

Valid August 1, 2025 – July 31st, 2026

TNBA - \$25.00

Valid September 1, 2025 – August 31, 2026

Financials: LOGSA will bank with Redstone Federal Credit Union.

League fees are as follows: Linage \$11.00 + Sec/Treasurer \$1.00 + Prize fund \$6.00 = \$18.00

LAST 2 WEEKS OF BOWLING WILL BE DUE BY WEEK 16

Grace period for vacancies on a team at the start of season is 2 weeks.

No team can be in arrears for more than 2 weeks. If a team is in arrears for more than 2 weeks, the team will forfeit all games until paid accordingly.

USBC Rules will be followed for collection of payments and for payments of team members that are temporarily not bowling.

Team Captain Duties: USBC 104a-b Please have all envelopes turned in by start of 2nd game.

League specifications

This League shall be called LOGSA Bowling League. The League is a handicap mixed League. The League shall bowl three games per night.

Team Handicap: The Team handicap shall be the sum of the bowler's individual handicaps. The team handicap shall not be limited.

Individual Handicap: The handicap shall be 100% of the difference between the bowlers' average and 220. The handicap shall not be limited. A *VACANCY* score shall be 120 with a handicap of 100. A *BLIND* score shall be the bowlers current average less ten pins.

Entering Averages: A bowler's book average shall be used for the first 9 games bowled. Returning bowlers from the 2024-2025 LOGSA League season will use their ending average with at least 21 games bowled. Non LOGSA League bowlers will use their highest USBC book average from the 2024-2025 season (21 games bowled). Bowlers without a USBC 2024-2025 book average will establish their handicap after 3 games are bowled.

Schedule: The league will bowl on Thursdays at 6:00, for 32 weeks beginning August 28th, 2025, at Redstone lanes. Shadow bowling with pins will start at 5:50, only 1 ball will be thrown. The League shall bowl on lanes 1 through 32. We will not bowl, November 27th (Thanksgiving) and December 25th (Christmas) or January 1st (New Year Day). There will be no other days off except in case of emergency. Payout will follow last position round night of bowling.

Position Rounds: LOGSA will have 2 position rounds, week 16 and week 32. No substitutes can bowl on position rounds or during the last two weeks of bowling. Bowlers on a team roster must meet the required games to bowl in position rounds. Position round 1 requires 9 games to be bowled prior to the position round. Position round 2 requires 15 games to be bowled prior to the position round. Any changes to this rule require a Board of Directors discussion and vote.

Legal Lineup: This League shall consist of 32 teams. Each team may have a maximum of six members on the team roster, with a playing strength of four bowlers. The minimum

legal lineup shall consist of two bowlers present for bowling from the team's current roster. The team roster must include at least one male and one female.

After the minimum legal lineup is met the remaining two bowlers may be bowlers on the current roster, sanctioned substitutes, or absent bowlers off the current team roster(blind). Of the four bowlers on the score sheet for each game bowled, at least one bowler must be female, and one bowler must be male.

New members may be added anytime a vacancy exists. No new members shall be added to the team roster during the last seven weeks of bowling without the approval of the board of directors. Pacers are not allowed.

Absentee/Vacancy USBC rule 112

Forfeits USBC rule 119

Teams having an incomplete roster, a vacancy on the team, will use a score of 120 per game with 100 pins handicap. All points must be earned. The same within-pin requirement will exist in a forfeit situation too.

Tardy Players: A bowler who arrives late may enter 1st game provided the 1st ball of the 4th frame has NOT been bowled. Tardy bowlers entering the 2nd and 3rd game must be present at the start of the 1st frame.

Postponements: Postponements may be granted ONLY when a legal lineup cannot be met. LOGSA league allows for 6 team members, therefore if part of your team will be on vacation etc., the team will not be allowed to pre or post bowl. In addition, there are limited times available for pre- and post-bowling. Unopposed bowling is authorized for teams only. A printout from Redstone Lanes will accompany the scoresheet for records purposes. Team captain must contact the team they are scheduled to bowl prior to requesting a postponement. Once that has been completed, the captains need to express their option for bowling to the league secretary.

Game Points: 1 point is awarded to the winner of each game, and 2 points is awarded to the winner of the series (total pin fall with handicap). Teams who tie will receive half point for the game and one point for the series.

Standings and Play-offs: 1st place tie will follow USBC rule 113. All other positions that tie will automatically share the place and split the prize fund for all positions occupied.

Prize List and Awards

The prize fund committee will consist of two League members and the secretary/ treasurer. Prize fund must be submitted for approval by the League board of directors within 5 weeks of the start of the schedule. MARYKAY CHARLIE GARRETT

LOGSA league prize fund will only play out 1st – 32nd Team placement. There will be no individual prizes.
